

Residency Classification For Alabama/Georgia Out-of-State Differential Tuition Plan Florida State University Panama City

Qualification is based upon documented evidence of a legal residence in one of the approved counties.

I am a US citizen, permanent resident alien or legal alien granted indefinite stay by the INS. I am a resident of one of the approved counties within Alabama/Georgia and I meet the residency requirements to qualify for differential out-of-state tuition fees based on the following criteria:

_____ A. I am an independent person (a person who provides more than 50% of his/her own support as defined by the Internal Revenue Service) who has established and maintained legal ties within an approved county within Alabama or Georgia.

OR

_____ B. I am a dependent person (a person for whom 50% or more of his/her support is provided by another as defined by the Internal Revenue Service) whose parent or legal guardian has established and maintained legal ties within an approved county within Alabama or Georgia.

OR

_____ C. I am a member of the armed services of the United States and I am stationed within one of the designated counties on active military duty pursuant to military orders or whose state of legal residence is Alabama/Georgia or I am a member's spouse or dependent child. **(Required:** Copy of military orders or DD2058; for spouse, also provide marriage certificate; for child, also provide current IRS return for parents).

Person claiming residency must complete this section in full

- Documents supporting the establishment of legal residence must be dated, issued, or filed **12 months before the first day of classes** of the term for which AL/GA resident classification is sought. All documentation is subject to verification.
- Additional documentation other than what is required above may be requested in some cases.
