

My name is Madison Nelson, and I began my career at the Bay County Sheriff's Office, where I served for nearly six years. During that time, I gained experience in multiple areas of law enforcement. I spent a year and a half in the Crime Scene Unit processing scenes and collecting evidence, one year on patrol as a Deputy Sheriff responding to calls for service, and three years in the Criminal Investigations Division. While in investigations, I specialized in violent crimes, tracked gang activity, and worked on undercover child exploitation cases.

## CSI Internship Highlight

Hi! My name is Cassie Mack. I recently graduated on August 1, 2025, with a Bachelor's degree in Public Safety and Security, majoring in Crime Scene Investigation and minoring in Underwater Crime Scene Investigation.

My career goal is to work with a police department or federal agency that specializes in violent crime. My internship took place during the summer semester, but I started it about two weeks late due to summer labs. I was able to increase my Capstone credit hours to 6 and worked more than the required hours, allowing me to gain more experience and avoid taking another elective class.

My internship was at the Metropolitan Police Department in Washington, DC, within their homicide unit. My hours typically consisted of Wednesday, Thursday, and Friday from 8:00 to 4:00; however, I occasionally did "ride-alongs" on some evenings to add to my hours.

I often arrived when my supervisor did, so she would immediately give me a task(s) for the day. My supervisor was a civilian; however, we worked directly with sworn detectives and officers. Most of my tasks consisted of watching surveillance footage to track vehicles or suspects. I would often speak with the detectives regarding which cameras they needed me to watch, as well as the specific timeframe. I spent most of my days doing these types of tasks; however, if a call came out, I would then go out with the detectives. Each death scene that I attended was natural and not a homicide. At these scenes, I saw how the detectives work closely alongside the officers and the forensics team. Some of the scenes that I attended were of overdoses, old age naturals, and occasionally the more rare

deaths, like a flooding accident inside an apartment complex.

DC is a very violent city with an average of about 250 homicides a year, so I can say that I was never bored. I would often work on up to 10+ cases at a time during the day.

During the internship, I sometimes felt extremely overwhelmed on certain days and could sense myself starting to spiral. I learned it is okay to take a step back from everything and take a deep breath.

I also learned not just to sit and watch, but to ask questions! No question is stupid, especially in this career field, where most of the information that you will learn is from watching others and asking questions. Never feel uncomfortable speaking up if you are confused or have questions. This is a learning experience for you, and your input may assist your coworkers learn something new.

The best advice that I can give current CSI students is to show your work ethic in school. One of the first things agencies do when considering you for an internship or job in their department is to investigate your academic work. The pride and effort you put into school will open up many more opportunities!

Some classes can be difficult, and some may be boring to you; however, do your best, no matter what, as that is what stands out for most jobs.

Another piece of advice I can offer is to maintain a good relationship with your professors. Your professors are the first steps toward networking and getting yourself out there. Don't be afraid to ask questions, whether in person or online, and don't feel embarrassed if you are struggling with specific subjects. Professors want to see that you're making an effort. Even if you are confused, asking shows your dedication and perseverance. Both will benefit you in your future career.

I hope this advice helps you with whatever you decide to do!
