Participation as an Early Walker does not equate to graduating, as that is separate clearance process that requires completion of all degree requirements and a separate application submitted during the student's final semester graduation application window. Ultimately, if a student is eligible for a degree of distinction upon graduating, that distinction will be automatically reflected on the student's official transcript.
