- ii. A Co-Chair is able to represent and vote on behalf of the Representative at a maximum of 2 SGC meetings per semester and at any SABA meeting in the absence of the Representative.
- iii. The title of Co-Chair may be revoked by request of the Representative with approval by a 2/3 officer vote.
- iv. A Representative is fully responsible for all actions, or lack thereof, of their Co-Chair.
- v. A Co-Chair must be eligible to serve on SGC in order for them to officially hold the title.
